Meridien Court Online is a social utility that connects people with friends and others who live around them. People use Meridien Court Online to keep up with neighbors, to share links, to share photos and videos of themselves and their friends, and to learn more about what is going on in their community. We want Meridien Court Online to be a place where people respect the rights and feelings of others, including third party intellectual property rights. Therefore, we have established certain rules for using Meridien Court Online and for posting messages, photos, video and other content ("Content") on Meridien Court Online, which rules are set forth in our Terms of Use and in this User Code of Conduct. WHEN YOU USE MERIDIEN COURT ONLINE, YOU ARE AGREEING TO ABIDE BY THE USER CODE OF CONDUCT AND THE OTHER RULES SET FORTH IN OUR TERMS OF USE. FAILURE TO ADHERE TO THIS CODE OF CONDUCT AND THE TERMS OF USE MAY RESULT, AMONG OTHER THINGS, IN TERMINATION OF YOUR ACCOUNT AND THE DELETION OF CONTENT THAT YOU HAVE POSTED ON MERIDIEN COURT ONLINE, WITH OR WITHOUT NOTICE, AS DETERMINED BY MERIDIEN COURT ONLINE IN ITS SOLE DISCRETION. ### **Third-Party Content**

Meridien Court Online allows you to upload and share user generated Content with your neighbors, such as photographs and videos you upload from your camera, webcam or mobile phone. This means that you may post and share original photographs and video that are of a personal nature that: (i) are of you or your friends, (ii) are taken by you or your friends, or (iii) are original art or animation created by you or your friends. It is not intended as a place for you to post third-party copyrighted content, such as the latest episode of a popular TV show or your favorite music video. In addition, we expect our users to use good judgment and respect the copyrights and other intellectual property rights of others. Therefore, in using Meridien Court Online, you may not:

- a) upload or share any photographs, videos or other Content other than original works that are created by you or another user
  
- b) post or share any Content that infringes upon or violates the copyright, trademarks or other rights of any third party
  
- c) attempt to circumvent any content filtering techniques we may employ
  
- d) Inappropriate Content

While we believe users should be able to express themselves and their point of view, certain kinds of speech simply do not belong in a community like Meridien Court Online. Therefore, you may not post or share Content that:

- a) is obscene, pornographic or sexually explicit
  
- b) depicts graphic or gratuitous violence
  
- c) makes threats of any kind or that intimidates, harasses, or bullies anyone
  
- d) is derogatory, demeaning, malicious, defamatory, abusive, offensive or hateful
  
- e) Unlawful or Harmful Content or Conduct

Court Online, you may not:

- a) violate any local, state, national or international law or post any Content that would encourage or provide instructions for a criminal offense
  
- b) impersonate any person or entity or otherwise misrepresent yourself, your age or your affiliation with any person or entity
  
- c) use Meridien Court Online to send or make available any unsolicited or unauthorized advertising, solicitations, promotional materials, "junk mail," "spam," "chain letters," "pyramid schemes," or any other form of solicitation
  
- d) post or share any personally identifiable or private information of any third party
  
- e) solicit passwords or personal information from anyone, including those under 18
  
- f) use information or content you obtained on the Meridien Court Online website or service in any manner not authorized by the Meridien Court Online Code of Conduct or Terms of Use
  
- g) post any material that contains software viruses or any other computer code, files or programs designed to interrupt, destroy or limit the functionality of any computer software or hardware or telecommunications equipment
  
- h) register for more than one account or use or attempt to use another's account, service or system without authorization or create a false identity on the Service or the Site
  
- i) engage in any predatory or stalking conduct
